## THE FERRARI GARDEN AND THE GLEDANICA ARCHAEOLOGICAL PARK

## GARDEN RULES

- The Garden at Villa Ferrari has been declared a cultural monument of national importance on the basis of the Ordinance Declaring the Garden at Villa Ferrari in Štanjel a Cultural Monument of National Importance (Official Gazette of the Republic of Slovenia Nos. 81/99, 55/2002 and 112/2004). The protection regime of the Ferrari Garden is laid down in Article 4 of the Ordinance referred to in the previous sentence.
- 2. Use of the garden is at the user's own risk.
- 3. In order to protect the cultural heritage, ensure the safety and well-being of visitors and safeguard general law and order, the following is prohibited in the entire area of the Ferrari Garden:
  - destruction of the garden's architectural design and historical remains;
  - polluting the water in the pool;
  - swimming, bathing and catching fish in the pool;
  - more than two persons accessing or staying on the bridge and the islet of the pool at a time;
  - children under 12 years of age accessing the bridge and the islet of the pool without being accompanied by an adult;
  - leaving younger children unattended:
  - picking flowers, cutting or damaging trees, ornamental shrubs, hedges of other plants and propagating material:
  - climbing trees, walls and other built structures in the garden;
  - destroying or damaging garden equipment;
  - attaching elements and devices serving an event to existing structures in the park (supporting walls, pillars, pergolas, tree trunks etc.);
  - littering and dumping of food and waste on the garden areas, refreshments for organised groups;
  - letting dogs off the lead and littering with dog faeces:
  - riding bicycles, horse-drawn carriages and motor vehicles;
  - shouting and noise nuisance;
  - making fires, sleeping in the garden;
  - picnicking;
  - staying near trees in strong gusts of wind.
- 4. The grassed areas by the pool and the boules court are rented primarily for cultural activities, in accordance with the Ordinance Declaring the Garden at Villa Ferrari in Štanjel a Cultural Monument of National Importance (Official Gazette of the Republic of Slovenia Nos. 81/99, 55/2002 and 112/2004).

- 5. For the purpose of the event, equipment may be installed in parts of the Ferrari Garden that does not damage the design or the remains of the garden, provided that the equipment is placed on hard surfaces (paths, boules court, under the pergola, in the access alley). The installation of equipment may be carried out with the prior agreement and consent of the owner of the garden and with the consent of the competent Institute for the Protection of Cultural Heritage.
- 6. Users of the areas shall ensure that they leave behind clean and tidy areas.
- 7. Visitors to the garden should use and stay in the reinforced areas of the garden as much as possible.
- 8. Visitors to the garden must obtain permission from the marketing services provider (ORA Krasa in Brkinov d.o.o.) for:
  - collecting seeds and other propagating material;
  - photographing and filming with a view to publicising the recordings;
  - any profit-making activity.
- 9. Any violation of the regulation are possible with a written authorisation by the owner.
- 10. Entry for organised groups with an accompanying person or guide (e.g. organised groups with a tourist guide, school groups with accompanying persons) is allowed on advance payment.
- 11. The event must finish at the time specified in the contract issued on the basis of the user's application. However, the event may be extended by agreement, which is evaluated accordingly.
- 12. If through negligence damage is caused to the area in use and its appurtenances, it shall be repaired by the owner of the property at the expense of the person(s) causing the damage. The owner shall invoice such person(s) for the damage.
- 13. The owner of the Ferrari Garden shall not be held liable for any damage caused by the theft of objects belonging to users of the premises.
- 14. Complaints regarding breaches of the Garden Rules should be addressed to the Municipality of Komen, which owns the property.
- 15. On the basis of the complaint, the authorities (municipal and state inspectors, each from their own area, and municipal wardens) impose penalties and order measures to remedy the irregularities found, and propose the initiation of offence proceedings.
- 16. The provisions 2, 3 and 7-14 are applied also to the Archeological Park Gledanica.
